Autopsy by Request	Request for Autopsy by Decedent Next of Kin (NOK), Law Enforcement Agencies, Other Counties and Insurance companies	<b>\$3,086.00</b>
Body Release - After Hours & Weekends	Release of Decedent Remains after "Normal" business hours (Mon - Fri before 8am/after 5pm & Weekends)	<b>\$38.00</b>
Body Storage	Storage of Decedent Remains. This fee is only imposed 72 hours after notification to NOK that remains are released for disposition.	<b>\$15.00</b>
Copy Fees - Autopsy Reports - In House Records	Copy/Print Charges for cases where casefile resides within the coroner facility or data system - First Report Copy to Family, Law Enforcement or Gov't Medical Agencies - Free of Charge	<b>\$11.00</b>
Copy Fees - Autopsy Reports - Off Site Records	Copy/Print Charges for cases where casefile is housed at County Archive Warehouse - First Report Copy to Family, Law Enforcement or Gov't Medical Agencies - Free of Charge	<b>\$97.00</b>
Copy Fees - Case Photos - Digital	Copy/Print Charges for reproduction of scene/autopsy photos - In Criminal Cases, two sets provided to District Attorney - Free of Charge	<b>\$11.00</b>
Copy Fees - Coroner Reports - In House Records	Copy/Print Charges for cases where casefile resides within the coroner facility or data system - First Report Copy to Family, Law Enforcement or Gov't Medical Agencies - Free of Charge	<b>\$11.00</b>
Copy Fees - Coroner Reports - Off Site Records	Copy/Print Charges for cases where casefile is housed at County Archive Warehouse - First Report Copy to Family, Law Enforcement or Gov't Medical Agencies - Free of Charge	<b>\$97.00</b>
Copy Fees - Xrays	Copy/Print Charges for reproduction of Xrays	<b>\$47.00</b>
Facility Use - No Support Staff (Per 8 Hours)	Use of 1 Autopsy Suite for 8 Hours - Includes Staff Set-up/Cleanup and Bio-Waste Disposal. Each additional 8 hour useage, or portion thereof, will result in additional charges	<b>\$187.00</b>
Facility Use - With Support Staff (Per 8 Hours)	Use of 1 Autopsy Suite for 8 Hours - Includes 8 hours of Coroner Technician support/assistance and Bio Waste Disposal. Each additional 8 hour useage, or portion thereof, will result in additional charges	<b>\$648.00</b>
Body Transportation (per S.C.C. 6.48.050)	Body Transportation Fee - Per S.C.C. 6.48.050 - Transportation of decedent remains from scene of death.	<b>\$400.00</b>
Vehicle Storage	Storage of Decedent Vehicle. This fee is only imposed 72 hours after notification to NOK that property is available for pickup.	<b>\$10.00</b>
